

# Community Property Research Guide

## Overview

This research guide contains information and resources on Community Property. Community property is defined as “assets owned in common by husband and wife as a result of these having been acquired during the marriage by means other than an inheritance by, or a gift or devise to, one spouse, each spouse generally holding a one-half interest in the property.” (*Black’s Law Dictionary, 11<sup>th</sup> ed.*). Texas is one of nine community-property states where property acquired during the marriage is equally owned by both spouses.
